### 德美利證券 如何處理您的個人資訊？

#### 為什麼？

金融公司選擇如何共用您的個人資訊。聯邦法律給予消費者權利以限制部分共用而不可全部共用。聯邦法律也要求我們告知您我們如何收集、分享和保護您的個人資訊。請仔細閱讀此通知以瞭解我們的做法。

#### 什麼？

我們收集和共用的個人資訊類型取決於您所使用的產品或服務。這些資訊可能包括：

- 社會安全號碼和財務帳號
- 帳戶餘額和交易資訊
- 收入和就業資訊

#### 如何？

所有金融公司都需要共用客戶的個人資訊來運行其日常業務。在下面的章節中，我們列出了金融公司共用其客戶個人資訊的原因；德美利證券選擇共用的原因；以及您是否可以限制這些共用。

## FACTS

### WHAT DOES TD AMERITRADE DO WITH YOUR PERSONAL INFORMATION?

#### Why?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

#### What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security number and financial account numbers
- Account balances and transaction information
- Income and employment information

#### How?

All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons TD Ameritrade chooses to share; and whether you can limit this sharing.

<b>Affiliates</b>	Companies related by common ownership or control. <b>Nonaffiliates</b>	Companies not related by common ownership or control. They can be financial and nonfinancial companies. <ul style="list-style-type: none"> <li>■ TD Ameritrade does not share with nonaffiliates.</li> </ul>
<b>Joint marketing</b>	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. <ul style="list-style-type: none"> <li>■ TD Ameritrade doesn't jointly market.</li> </ul>
