- 2. Enable advanced features during the futures application process


Note: If you already have these requirements, you will go straight to the futures application. If you do not, you will be prompted to enable one or both requirements prior to applying

Please note:

- If you are applying to trade futures in an IRA, you will need to have a minimum net liquidation value (NLV) of \$25,000. Only SEP, Roth, traditional, and rollover IRAs are eligible for futures trading.
- · Forex trading is not allowed in any IRA

To check if you have these elections enabled on your account:

Please log in at <u>tdameritrade.com</u>. Once logged in, click on the Client Services tab and choose My Profile (General) from the dropdown menu.



Margin

Locate the Elections and Routing section. In the line entitled Margin Trading, it should say Enabled. If it does not, you will first need to apply for margin before you can apply for futures or forex. To start the margin application, click the Enable link. If Margin Trading is enabled, the next step is to check your options approval level.

Options

Locate the line that says Option Trading (the line directly below Margin Trading). You will need to have a minimum of Tier 2 standard margin option approval. If you do not have this, click the Edit link to the right to apply for a higher level of options trading.

Please allow 1-3 business days for processing of applications.

Applying for futures and/or forex

If you have met the minimum account requirements to apply for futures and/or forex, please log in at <u>tdameritrade.com</u>. If margin, or options were recently enabled, you will need to allow an overnight update to occur. Once logged in, click on the Client Services tab and choose My Profile (General) from the dropdown.



Locate the Elections and Routing section. Locate the line(s) entitled Futures and/or Forex and click the Apply link.
